

**TERMS AND CONDITIONS**

**TERMS AND CONDITIONS OF BUSINESS CARRIED OUT BETWEEN THE AGENT UNITED PRODUCTIONS (UP) & THE ARTIST FOR THE INTRODUCTION OF CLIENTS.**

- 1 **UP** is an agency that endeavours to obtain assignment for all those persons registered with the agency.
- 2 All **ARTISTS** signed with **UP** will be responsible for their own Tax and NI payments.
- 3 **ARTISTS** are responsible for their own insurance both public and personal liability. All circus acts must have up to date public liability insurance  
b) **UP** will not be held responsible for any loss, damage or injury caused to or by any **ARTISTS** while working on or travelling to any assignment issued by **UP**.
- 4 **UP** will cease to represent any person whose conduct brings the agency into disrepute.
- 5 By signing this agreement, the **ARTISTS** consents **UP** to use any available online footage/images of the dancer during the term of representation.
- 6 Once a booking has been accepted, the **CLIENT** and **ARTISTS** will be expected to honour the said booking. Once agreed **VERBALLY**, **ELECTRONICALLY** or in **WRITING**, both parties will be subject to a legally binding contract. Withdrawal or failure to fulfil said obligation will result in dismissal of the agency. Penalty fee may apply.
- 7 **THE ARTIST** shall not endeavour to contact **THE CLIENT** directly nor solicit work from **THE CLIENT** or any companies associated with **THE CLIENT**.
- 8 Any **ARTISTS** who attend auditions / castings / interviews with a **CLIENT** that has been arranged through **UP** must then be booked through **UP** for the said assignment and any future assignments.
- 9 Where the **ARTIST** is initially rejected by **THE CLIENT** or initially rejects **THE CLIENTS** offer of employment and is subsequently employed by said **CLIENT** in any capacity up to a period of twelve months of leaving or dismissal from **THE AGENCY**, **THE ARTIST** shall be responsible for the payment of commissions resulting from such employment to **UNITED PRODUCTIONS (UP)**
- 10 • **THE ARTIST** must not discuss any details regarding the booking with any unauthorised party. **THE ARTIST** must consult **UP** prior to posting any footage from the booking on Social Media.
- 11 All bookings: **UP** Agency charges a commission on all hourly/daily and usage fees.  
These are as follow:  
a) **12.5%** on gross from Theatre contracts, musicals and plays on equity contract.

- b) **20%** on gross from TV and Cinema Commercials, Films, TV Station Ident's, Music Shows, Video operate/trade/promotional/photographic
- c) Travel costs unless stated on booking are not covered.

**All commissions are subject to VAT at standard rates.**

**12 UP** will not be held responsible for cancellation fees unless stated on specific assignment details.

**UP** will not be held responsible for **THE CLIENTS** bad debts but will endeavour to take every action to regain any loss of earnings should **THE CLIENT** fail to pay.

**13** Any amendments to any assignments of fee's must be negotiated through **UP**. These terms and conditions apply to all assignments issued through **UNITED PRODUCTIONS (UP)**.

**14 UP** reserve the right to alter these terms and conditions provided written notice is given.

**15 UP** invoice the client the day after any completed assignment (or first working day thereafter) and they then have 30-90 working days to pay **UP** (This depends on the client, international and commercial clients may take longer). Consequently, we then pay the **ARTIST** as soon as this payment is clear in our account.
